Dream Car Raffle

Official Raffle Rules to Win ARC's Raffle Vehicle

1. Void where prohibited by law.
2. Eligibility: Anyone 18 or older may enter (ID will be required to verify age). Board members, Directors and Officers of the Rec. Centers of Sun City, Inc. and the Automotive/Restoration Club of Sun City West may participate in the raffle, but may not receive any direct or indirect pecuniary benefit from the Dream Car Raffle.
3. Raffle period will be for one year starting February 14, 2017, and ending February 10, 2018,
4. Tickets: Two-part, sequentially numbered raffle tickets will be sold at the following rate:
 - a. 1 ticket @ \$10.00
 - b. 3 tickets @ \$25.00
 - c. 15 tickets @ \$100.00
5. Drawing for a winner will be held on Saturday, February 10, 2018, at 2:00 PM Mountain Standard Time at the R.H. Johnson Rec. Center, 19803 R.H. Johnson Blvd., Sun City West, AZ 85375. There will be no ties.
6. The winner will be notified immediately following the drawing using the information provided by the purchaser of the ticket by telephone and/or certified mail. In addition, the winner's name will be posted on the bulletin board at the Rec. Center of Sun City West. The winner need not be present to win.
7. The winner must claim the vehicle within 30 days of the postmarked notification of winning.
8. The winner is responsible for making their own arrangements for delivery of the vehicle within 30 days of the drawing as well as paying for the delivery.
9. The winner assumes all fees, local, state and federal taxes (including but not limited to income taxes based on the value of the vehicle, DMV tax and fees) which must be paid when the vehicle is transferred to the winner. Winner will be responsible for vehicle insurance (proof of insurance from the winner will be required on the vehicle before the vehicle may be moved).
10. The vehicle will be transferred to the winner **As Is, Where Is, and with all faults**. The Rec. Center does not provide any guarantee or warranty, expressed or implied, in connection with the car and accepts no liability or responsibility regarding the condition of the car. The Rec. Centers does not warrant that the car is of merchantable quality or that it can be used for any particular purpose. No express warranties are given and no affirmation of the Rec. Center by words and/or actions will constitute a warranty.
11. If the name of more than one person is submitted with a ticket purchase and that ticket is selected as a winning ticket, then the person named first will be deemed the holder of record of that ticket and declared the winner. Division of the prize by a group purchasing a ticket in common shall be to the sole responsibility of the person named as the holder of record of that ticket, should that ticket be selected as a winner.
12. If a winner does not claim the vehicle within 30 days of the postmarked notice using the information provided on the ticket, such winner will be deemed to have forfeited their opportunity and a second raffle ticket will be drawn.
13. The Rec Centers of Sun City West, Inc. will file all paperwork with all involved governmental agencies regarding reporting the winner of the Dream Car Raffle.

14. Winner agrees to complete all appropriate and applicable forms requested as well as pay 25% federal income tax withholding to the Rec. Centers of Sun City West, Inc. prior to release of the vehicle. The Rec. Centers of Sun City West, Inc. will submit the taxes collected to the IRS. The Rec. Centers of Sun City West, Inc. will file all forms necessary with the IRS to report the value of the prize won and the taxes paid in by the winner. The winner will also receive a copy of a W-2G.
15. The odds of winning the vehicle will depend on the number of tickets sold.
16. Note: The IRS has taken the position that amounts paid for chances in raffles, lotteries or similar drawings for valuable prizes are not gifts, and consequently do not qualify as deductible charitable contributions.
17. By entering this raffle, entrants accept and agree:
 - a. To be bound by all the rules, limitations and restrictions set forth here and
 - b. That their names and/or likenesses may be disclosed to and used by the news media and may otherwise be used by the Rec. Centers of Sun City West, Inc. for publicity purposes and in a listing of the prize winner to be published in area newspapers and announced on the Internet.
